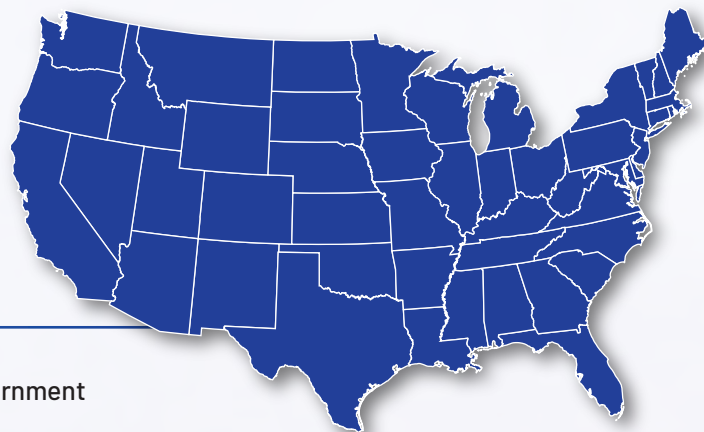

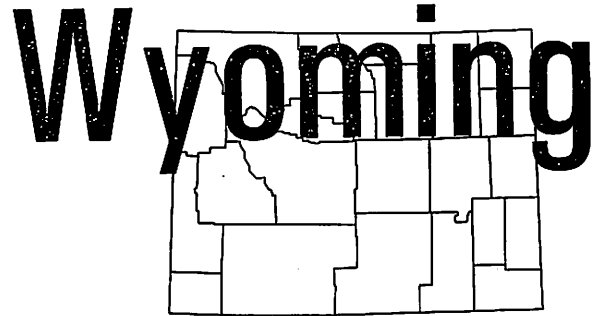

State Agencies

Criminal Records

Division of Criminal Investigation, Criminal History Records Unit, 208 South College Dr, Cheyenne, WY 82002; 307-777-7181, Fax- 307-777-7252; 8AM to 5PM.

A record inquiry includes all reported felonies, high misdemeanors and other specified misdemeanors, but not municipal ordinance violations. If authorized by state law, the check may include federal records held by FBI.

Indexing & Storage: Records available from 1941 on. New records available for inquiry in 48 hours.

Searching: First, obtain a Request for Criminal Record Packet from the address above or by telephoning this agency. Include in request- name, set of fingerprints, date of birth, and Social Security Number. Use the FBI standard 8" x 8" blue fingerprint card. All requests are fingerprint based. Must also complete all information and waiver is on the back of this office's fingerprint card. This data not released: juvenile records if no guardian consent. Records include all felony and major misdemeanor arrests and convictions. Per a 2012 U.S. DOJ Study, 84% of all arrests in database have final dispositions recorded, and 5% of all dispositions received cannot be matched to a specific arrest record.

Access by: mail, in person, .

Fee & Payment: The search fee is \$15.00 plus an additional \$5.00 if this office must perform the

fingerprinting. The fee is \$10.00 if the applicant is providing volunteer services, plus the fingerprinting fee if applicable. The FBI fingerprint check is an add'l \$24.00. Fee payee: Office of the Attorney General. Prepayment required. Money order, cash or certified checks only. Personal checks not accepted. No credit cards accepted.

Mail search: Turnaround time: 2 to 4 weeks. A SASE is requested.

In person search: Proper forms are required to be filled out.

Wyoming law defines a sex offender subject to registration as a person convicted of a sex offense in which the victim was a minor and the offender was at least eighteen (18) years of age or an aggravated sex offense.

Indexing & Storage: Records available as county submits them.

Searching: The County Sheriff's Office or other law enforcement agency maintains a file and forwards the information to the Wyoming Division of Criminal Investigation (DCI). Division of Criminal Investigation (DCI) is required to post all registered sex offenders on an internet site

accessible to the citizens of Wyoming or elsewhere.

Online search: The Internet is the search method offered by this agency to the public. Search by last name, street name, city, county or ZIP or radius map. See <http://wysors.dci.wyo.gov/sor/search.htm>. Data includes name including AKA, physical address, date and place of birth, date and place of conviction, crime for which convicted, photograph and physical description. Indexing & Storage: Records available on current and former inmates. New records available for inquiry in a minimum of 30 days.

Searching: No searching online direct from this agency; a vendor provides access to DOC records at <https://www.vinelink.com/index.jsp>. Include in request- full name. DOB and SSN are helpful. Location, conviction and sentencing information, and release dates are provided. Limited search requests honor via email at mbrazz@wdoc.state.wy.us. This data not released: probation and parole data, medical, and mental health problems.

Access by: mail, phone, fax, .

Fee & Payment: The fee is \$.50 per page. Fee payee: Wyoming Dept of Corrections Prepayment required. Personal checks accepted.

Mail search: Turnaround time: 1 to 2 weeks. A SASE is requested.

Phone search: Name searching available.

Fax search: Can request via fax.

Statewide Court Records

The Supreme Court of Wyoming is the court of last resort. There is no intermediate court of appeals. Most cases docketed in the Supreme Court are appeals from District courts. This docket is searchable from the web page.

Searching: Except for certain online research capabilities, all court record access must be done at the local level. Effective January 1, 2011 records have redacted the birth day and month and the first 5 digits of an SSN on public record pleadings and exhibits filed at the courts for documents seen by the public.

Online search: Supreme Court opinions are available at the home page, listed by date. Wyoming's statewide case management system is for internal use only. Planning is underway for a new case management system that will ultimately allow public access.

Indexing & Storage: Records available from 1800s on. The records on microfilm are inactive records before 1983. Newer records are on computer. New records available for inquiry immediately.

Searching: The Annual Report financial information (Appendix I Worksheet filed with Annual Report) is not released. Include in request- full name of business. In addition to the articles of organization, business entity records available include: Annual Reports, Officers, Directors, DBAs, Prior (merged) names, Inactive and Reserved names. This data not released: worksheet material for annual report.

Access by: mail, fax, in person, online.

Fee & Payment: First 10 copies free, if non-certified. Otherwise, copy fees are \$.50 per page for the first 10 pages and \$.15 for each additional page. Certification is \$3.00. Fee payee: Secretary of State. They will invoice for copies and certificates. Prepaid accounts are available. Personal checks accepted. No credit cards accepted.

Mail search: Turnaround time: 2-5 days. A SASE is helpful.

Fax search: Turnaround time is 2-5 days.

In person search: Counter service available.

Online search: Information is available at <https://wyobiz.wy.gov/Business/FilingSearch.aspx>. You can search by corporate name or registered filing ID. Validate or generate a Certificate of Good Standing at <https://wyobiz.wy.gov/Business/ViewCertificate.aspx>, this is free. Search trademarks at <http://will.state.wy.us/trademarks/>.

Indexing & Storage: Records available since 1982.

Searching: The search includes federal tax liens on businesses and state tax liens filed by state agencies. Include in request- debtor name. This data not released: SSNs

Access by: mail, fax, in person, online.

Fee & Payment: A certified search is \$10.00 per name. Copies cost \$.50 each. Fee payee: Secretary of State. Personal checks accepted. No credit cards accepted.

Mail search: Turnaround time: 3 days. Please include your phone number with all requests.

Fax search: Requests may be faxed in.

In person search: Simple requests may be processed while you wait.

Online search: One may email requests to SOSRequest@wyo.gov. The online filing system permits unlimited record searching, see <https://ucc.state.wy.us/ExLogin.asp>. Subscribers are entitled to do filings at a 50% discount. There is a \$150 annual fee, with no additional fees charged for searches. Visit the webpage for more information.

Other access: Lists of filings on CD or diskette are available for purchase. Download the database for \$2,000 per year.

State Tax Liens

Records not maintained by a state level agency.

Federal tax liens on personal property of businesses are filed with the Secretary of State. Other federal and all state tax liens are filed with the County Clerk. There is no state income tax in WY.

Indexing & Storage: Records available for at least three years: cancelled licenses are purged every two years at discretion of administration. New records available for inquiry in 2 to 3 days.

Searching: This agency will only confirm that the business is registered. They will provide no other information except to an owner or officer of the

business. Requests may be e-mailed, visit the website for the proper e-mail address. Include in request- business name, and ID of the requester. They will also search by tax permit number. Annual reports may be retrieved from the webpage.

Access by: mail, phone, in person, .

Fee & Payment: For paper copies or from microfilm, copy fee is \$.50 each first 10 pages, \$.15 each add'l with a \$10.00 minimum. For computer images, copy fee is \$1.00 per page first 10 pages, then \$.30 each additional with a \$35.00 minimum. Fee payee: WY Dept of Revenue

Mail search: Turnaround time: 7 to 10 days. A SASE is requested. No search fee for mail request.

Phone search: No search fee for telephone request.

In person search: No search fee for request.

Indexing & Storage: Records available from July 1909 to present. After 100 years from the date of the event, birth certificates can be obtained by anyone providing enough information to locate the record. Get records through the Wyoming State Archives at 2301 Central Ave, Cheyenne, WY 82002. New records available for inquiry immediately.

Searching: Must have a signed release from person of record or parent or guardian. Include in request- full name, names of parents, mother's maiden name, date of birth, place of birth, relationship to person of record. Must include signature of requester and copy of photo ID.

Access by: mail, in person, .

Fee & Payment: Search fee is \$13.00 per name per 5 years searched. Fee payee: Vital Records Services. Prepayment required. Personal checks and money orders only accepted. Enclose SASE with request.

Mail search: Turnaround time: 8 to 10 working days. SASE is required.

In person search: Turnaround time is same or next day.

Expedited service: The only expedited service offered is to supply a pre-paid, self-addressed envelope for FedEx, UPS, or US Postal express mail.

Indexing & Storage: Records available from July 1909. After 50 years from the date of the event, records may be obtained by anyone providing enough information to locate the record in question. Get records through the Wyoming State Archives at 2301 Central Ave, Cheyenne, WY 82002. New records available for inquiry immediately.

Searching: Records are not open. Must have a signed release from immediate family member. The agency will verify information to family

member, such as aunts and uncles, but will not release copies. Include in request- full name, date of death, place of death, relationship to person of record, reason for information request. Must include signature and copy of photo ID with request.

Access by: mail, in person, .

Fee & Payment: Search fee is \$13.00 per name per 5 years searched, or \$10.00 if date given. Fee payee: Vital Records Services. Prepayment required. Personal checks and money orders only accepted. Enclose SASE with request.

Mail search: Turnaround time: 8-10 working days. SASE is required.

In person search: Turnaround time is one day.

Expedited service: The only expedited service offered is to supply a pre-paid, self-addressed envelope for FedEx, UPS, or US Postal express mail.

Indexing & Storage: Records available from May 1941 to present. After 50 years from the date of the event, records may be obtained by anyone providing enough information to locate the record in question. Get records through the Wyoming State Archives at 2301 Central Ave, Cheyenne, WY 82002.

Searching: Must have a signed release from persons of record. Include in request- names of husband and wife, date of marriage, place or county of marriage, relationship to person of record, reason for information request, wife's maiden name. Signature and copy of photo ID must be included in request.

Access by: mail, in person, .

Fee & Payment: Search fee is \$13.00 per name per 5 years searched. Fee payee: Vital Records Services. Prepayment required. Personal checks and money orders only accepted. Enclose SASE with request.

Mail search: Turnaround time: 8 to 10 working days. SASE is required.

In person search: Must return to pick up in 24-48 hours.

Expedited service: The only expedited service offered is to supply a pre-paid, self-addressed envelope for FedEx, UPS, or US Postal express mail. Add \$18.25 for credit card fee and courier delivery.

Indexing & Storage: Records available from May 1941 to present. After 50 years from the date of the event, records may be obtained by anyone providing enough information to locate the record in question. Get records through the Wyoming State Archives at 2301 Central Ave, Cheyenne, WY 82002. New records available for inquiry immediately.

Searching: Must have a signed release from person of record. Include in request- names of husband and wife, date of divorce, place of divorce, relationship to person of record, along with release. Include copy of photo ID with request.

Access by: mail, in person, .

Fee & Payment: Search fee is \$13.00 per name per 5 years searched. Fee payee: Vital Records Services. Prepayment required. Personal checks and money orders only accepted. Enclose SASE with request.

Mail search: Turnaround time: 8 to 10 working days. SASE required.

In person search: Must come back to pick in 24-48 hours.

Expedited service: The only expedited service offered is to supply a pre-paid, self-addressed envelope for FedEx, UPS, or US Postal express mail.

Indexing & Storage: Records available from 1950's on computer. Records are on microfiche from 1919 to 1987. Searches on microfiche must include the date of injury, county of injury, employer and body part affected. New records available for inquiry in 3 days or more.

Searching: Only the injured party, employer or legal counsel for either party can obtain records from this agency. The agency will provide a post-hire check of a new employee, but limited information is given. A signed release with SSN is needed. Include in request- claimant name, date of injury, Social Security Number. The only information released is case #, date of injury, body part, employer at time of injury, or other information specifically authorized by claimant. A Release of Information form is found at the web page.

Access by: mail, fax, .

Fee & Payment: No search fee. The copy fee is \$.25 per copy. Fee payee: Wyoming Workers' Compensation

Mail search: Turnaround time: variable. Send release form with request to the address above. SASE not required.

Fax search: They will accept fax requests for post hire requests. One may fax a list with name and SSN, a list will be returned with case numbers.

Indexing & Storage: Records available for 3 years from offense date for moving violations and certain admin action, and 5 years for sever records

such as DUI. A 10 year record can be requested. Accidents are shown only if driver fails to show Fin Resp. New records available for inquiry immediately.

Searching: Companies requesting records must complete and file the DPPA form found on the website. Casual requesters cannot obtain records with personal information without signed release from subject. Include in request- name and DOB and DL or SSN. This data not released: medical information.

Access by: mail, fax, in person, online.

Fee & Payment: The fee is \$5.00 per record. If Add \$2.50 if credit card used. Fee payee: Department of Transportation. Prepayment required. Personal checks accepted. Credit cards accepted for fax or mail requests.

Mail search: Turnaround time: 3 - 5 business days. An SASE is not required.

Fax search: Fax requests are accepted with payment by credit card or electric check.

In person search: Normal turnaround time is while you wait. Individual licensees may request a copy of their own record at any field office.

Online search: Electronic access is available using Web service, fee is \$5.00 per record. Only approved vendors and permissible users are supported. Call Marianne Bixler at 307-777-4830 or write to the above address for details.

Other access: The entire driver license file may be purchased for \$2,500 with an additional fee for monthly updates. This is only available with a signed contract and compliance with the DPPA.

District Courts indexed by defendant, plaintiff, and by case number. Bankruptcy Courts usually index by debtor and case number. Most case files created prior to 1999 were maintained in paper format only. Since 2006, all cases are filed electronically. Paper case files may be stored at the courthouse or forwarded to a designated Federal Records Center (see <http://archives.gov/frc>), the timeframe determined by the Court. These case files may be obtained via the Court or directly from the FRC.

Case data may be viewed PACER, the online public access program. An account is required, the fee is \$.10 per page; there is no fee if a usage does not exceed \$15.00 in a quarter. For details about PACER see the Appendix or go to <https://www.pacer.gov> or call 800-676-6856.

The copy fee is \$.50; \$.10 if electronic document is printed from terminal. Certification fee is \$11.00 per document and \$21.00 for exemplification, if available. Details on the Court Structure

Each county has a **District Court** which oversees felony criminal cases, large civil cases, and juvenile and probate matters. The clerk of district court is the record keeper of the court.

The **Circuit Court** is of limited jurisdiction and oversee civil cases when the amount sought does not exceed \$50,000 (raised from \$7,000 effective 07/2011) and small claims to \$5,000. Circuit Courts also hear family violence cases and all misdemeanors. Three counties have two Circuit Courts each: Fremont, Park, and Sweetwater. Cases may be filed in either of the two court offices in those counties, and records requests are referred between the two courts. At one time the Circuit Courts were known as Justice Courts. Effective January 1, 2003, all Justice Courts became Circuit Courts and follow Circuit Court rules. A Circuit Court may also have the jurisdiction of a municipal court over ordinance violations if requested by a municipality.

Municipal Courts operate in all incorporated cities and towns; their jurisdiction covers all ordinance violations and has no civil jurisdiction. The Municipal Court judge may assess penalties of up to \$750 and/or six months in jail.

Fees and Record Searching Tips

Record Searching Facts You Need to Know

Fees for searching and record copies are set statewide by Rule. Most courts follow these guidelines; the search fee is \$10.00 per name, the copy fee is \$1.00 for the first page and \$.50 each add'l. The Rule for sending or receiving a fax is \$1.00 per page. Certification fees vary.

All Circuit Courts have public access terminals (PAT) installed. But less than half of the District Courts have PATs.

Mandated Redaction: A State Rule effective January 1, 2011 directed redaction of the birth day and birth month and the first 5 digits of an SSN on public record pleadings and exhibits filed at the courts. From this date forward, the courts have two copies of each document – one public that is redacted, and one non-public that contains the full DOB and SSN.

It is important to note that some courts have chosen to redact these partial identifiers on all prior cases filed, not just since 01/01/11.

Online Access is Non-Existent

Wyoming's statewide case management system is for internal use only. Planning is underway for a new case management system that will ultimately allow public access. But at this time there is no online access to civil, criminal, or other court case files or dockets.
