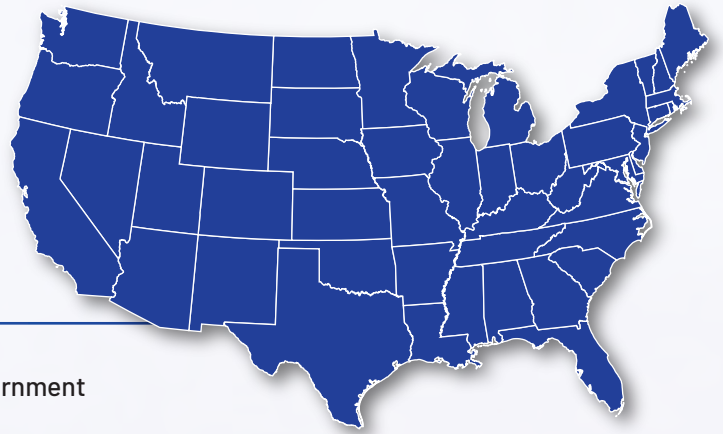

Criminal Records

The New Mexico State Central Repository for Criminal History maintains arrest record information on persons arrested in NM for felony, misdemeanor (offenses punishable by six months or more imprisonment) and DWI offenses.

Indexing & Storage: Records available from 1935 on. New records available in 2 to 4 weeks.

Searching: Fingerprint search requests are not available except for checks for children or elderly-related occupations mandated by state statute, and an FBI search can be done for those groups. The state's records are 100% fingerprint-supported. Include in request- date of birth, Social Security Number, full name, and the DPS notarized signed release by subject. Download the release form at www.dps.state.nm.us/wp-content/uploads/Authorization-for-Releaseof-Info-Frm.pdf. Those eligible for an FBI fingerprint check must be registered. This data not released: juvenile records. Many records may not have the dispositions. The agency urges requesters to check with the courts. All records are released, including

those without dispositions. This includes arrest record information on persons arrested in New Mexico for felony, misdemeanor (offenses punishable by 6 months or more imprisonment) and DWI offenses.

Access by: mail, in person, .

Fee & Payment: The fee is \$15.00 for the "State Background Check." A Letter of Good Standing is \$18.00. If the agency does the fingerprinting, the fee is \$9.00 for first two cards and \$2.50 ea add'l. Fee payee: Department of Public Safety. Prepayment required. Must use cashiers check or money order. No credit cards accepted.

Mail search: Turnaround time: 1 to 3 weeks. Turnaround time is for "no record found." If records exist, turnaround time may be 3 to 4 weeks. A SASE is requested.

In person search: If records are found, they may be available in 5 to 7 working days.

Indexing & Storage: Records available from 07/95. New records available in 2 to 4 weeks.

Searching: Email questions to dps.sorna@state.nm.us. Include in request- name, DOB. The work address belonging to a sex offender is released if he/she will come into direct contact with children. This data not released: SSN

Access by: mail, phone, online.

Fee & Payment: There is no fee. Copies are \$1.00 first page, \$.25 ea add'l. Personal checks accepted.

Mail search: Turnaround 7 days, SASE requested.

Phone search: Name searching available by phone.

Online search: The OffenderWatch program at <http://sheriffalerts.com/counties.php?state=nm> offers a variety of search methods including by name, county, city, and ZIP Code. The site also offers a complete state list and an absconder list.

Indexing & Storage: Records available on current and former inmates. New records available for inquiry in 1-3 days.

Searching: Note, the New Mexico Corrections Department does not have jurisdiction over the County or City Detention Facilities. Include in request- name; DOB and SSN are helpful. Location, conviction and sentencing information, behavior, release dates are provided. This data not released: NCIC, police reports, pre-sentence, parole data.

Access by: mail, phone, online.

Fee & Payment: Fee is \$.25 per copy. Fee payee: NM Department of Corrections Prepayment required. Personal checks not accepted. Credit cards not accepted.

Mail search: Turnaround time: 7 to 10 days. A SASE is not required.

Phone search: Limited name searching available.

Online search: The search site is <http://corrections.state.nm.us:8080/OffenderSearch>

Other access: A data subscription service is available. See details at www.corrections.state.nm.us/offenders/NMCD_DATA_REQUESTS.pdf. Data may NOT be resold.

Indexing & Storage: Records available since 1997, in general. Some county records may go back farther. New records available in 48 hours.

Searching: This data not released: sealed, restricted, or party information.

Online search: There is free access to District and Magistrate Court case information, except Bernalillo Metro which has its own system, at www.nmcourts.gov/caselookup/app. Municipal court data is limited to criminal Domestic Violence and DWI historic convictions from September 1, 1991 forward. In general, the other records are available from June 1997 forward. The search is inclusive of all counties participating. Search by name & DL and/or DOB, and by county and type of case or by case number. Only the year of birth is displayed. The site also offers a DWI Offender History tool for researching DWI history at www.nmcourts.gov/dwi.php.

Indexing & Storage: Records available for all entities on microfilm. New records available for inquiry in 1-2 days.

Searching: Include in request- full name of business. In addition to the articles of organization, business entity records available include: Annual Reports, Officers, Directors, Prior (merged)

names, Inactive, Registered and Reserved names. This data not released: financial information.

Access by: mail, phone, fax, in person, online.

Fee & Payment: There is no charge for a computer printout. Copies are \$1.00 per page with minimum fee of \$10.00 for for-profit companies or domestic LLCs and \$5.00 for non-profit entities. Certification fee is \$25.00, except for non-profits which is \$10.00. Fee payee: NM Secretary of State Prepayment required. Personal checks and money orders accepted. No credit cards or cash accepted.

Mail search: Turnaround time: 4-10 days. A SASE is requested.

Phone search: Limited information is given over the phone.

Fax search: Information can be requested by fax, but is not returned until payment received.

In person search: Search requests can be made in person, timeframe of results depends on how extensive research is.

Online search: There is no charge to view records at the Internet site see <https://portal.sos.state.nm.us/corps/%28S%28m4xk3itansvju55yqo0snbgs%29%29/Corplookup/lookdn.aspx>. Records can be searched by company name, agent or director. Search partnership information at <https://states.recordfusion.com/countyweb/login.do?countyname=NMSoS>. Expedited service: Expedited service is available, but only with supervisor approval.

Since July 1, 1997, New Mexico no longer registers trade names. However, the agency will do searches for records on file.

Indexing & Storage: Records available from 1980 to present. New records available for inquiry in 7-10 days.

Searching: Include in request- trademark/service mark name. Include your full name, address and telephone number.

Access by: mail, phone, fax, in person, .

Fee & Payment: There is no search fee, copies are \$.25 a page. Fee payee: Secretary of State. Prepayment required. Personal checks accepted. Credit cards not accepted

Mail search: Turnaround time: 2 to 3 days. SASE not required. No fee for mail request.

Phone search: They will do a computer search and will give you the information over the phone for no fee.

Fax search: There is no fee. Turnaround time: 24 hours.

In person search: No fee for request. Turnaround time is usually immediate.

Other access: File copies may be purchased in bulk, but same \$.25 per copy fee applies.

This agency will not conduct searches. You must hire a local search company or conduct your search via the agency website.

Indexing & Storage: Records available from 1965, but most available records are from 1998 forward. New records available for inquiry in 24 hours.

Searching: Please note all tax liens are filed at the county level. For data on agricultural liens see www.sos.state.nm.us/Business_Services/Agricultural_Liens.aspx. The system does not permit a search by collateral. Searching is not permitted by mail, phone or fax, but the agency will look up an image if a specific file number is given. This data not released: SSN or tax IDs.

Access by: mail, fax, in person, online.

Fee & Payment: Copies are \$1.00 per page, plus \$3.00 if certification requested. Also, a fee of \$1.00 per page is assessed on all UCC copy requests for UCC filings that were filed prior to June 30, 1998. Fee payee: Secretary of State. Prepayment required. Personal checks accepted. No credit cards accepted.

Mail search: Turnaround time: 3 days. No name requests by mail, you must give specific document number. SASE is requested.

Fax search: Fax requests accepted if file number provided; search requests by name not accepted.

In person search: A public access terminal is available. You may view documents for free.

Online search: The website <https://portal.sos.state.nm.us/BFS/online> permits searching by name, organization, or file number. The site is not supported by some browsers, something to do with SSL certificates with 1024-bit RSA keys.

Other access: Microfilm and images (from 7/99) on disk may be purchased.

Federal & State Tax Liens

Records not maintained by a state level agency.

Records are filed with the Clerk at the county level.

New Mexico does not have a sales tax. It has a gross receipts tax instead.

Indexing & Storage: Records available from 1996. New records available f in one week.

Searching: This agency will only confirm that a business is registered and active. They will provide no other information. Include in request- company name or ID# plus information on the requesters (name, address, telephone number). The business name is required, the permit number and federal ID are optional.

Fee & Payment: If you would like a copy of a public record, the records custodian may charge a reasonable fee. The fee for documents 11x17 or

smaller is \$.25 per page. The fee for larger documents is under review.

Mail search: Turnaround time: 6 to 12 weeks. A SASE is requested.

In person search: Simple requests processed immediately.

All requesters must sign and date the request. It is a felony to obtain a record fraudulently. Please note that on the 1st Tuesday of every month, the counter is closed from 11AM to 4PM

Indexing & Storage: Records available from 1920 on. Birth certificates become public records one hundred (100) years after the date of birth. New records available for inquiry immediately.

Searching: Records available only to immediate family members or those demonstrating legal tangible interest in the desired record. Sealed records (e.g. adoptions and paternity) are unavailable. Include in request- full name, names of parents, mother's maiden name, date of birth, place of birth, relationship to person of record, reason for information request. Signature of requester and physical & mailing addresses are required. There is a suggested form that may be downloaded from the web page. The form is also available in Spanish.

Access by: mail, phone, in person, online.

Fee & Payment: The search fee is \$10.00 per record. Additional fees are charged by the vendor. Fee payee: NM Vital Records. Prepayment required. Personal checks accepted. Major Credit cards accepted only by VitalChek.

Mail search: Turnaround time: 6 weeks. SASE not required.

Phone search: See expedited services.

In person search: Turnaround time is usually less than 1/2 hour. Also, counter service for requesting birth certificates through the Albuquerque Stanford Public Health Office is available Monday through Friday from 9:00 a.m. until 4:00 p.m.

Online search: Online ordering is provided by a state designated vendor - www.vitalchek.com.

Expedited service: Expedited service is available for phone and fax requests from www.vitalchek.com. Fees are charged, including delivery if needed.

Indexing & Storage: Records available from 1920 to present. New records available for inquiry immediately.

Searching: Records are restricted until 50 years after the date of death. Only immediate family member or a person with tangible interest can receive record. Include in request- full name, date of death, place of death, SSN, relationship to person of record, reason for information request. Age at death and name of mortuary must also be included for search. Signature of requester and

physical & mailing addresses are required. A suggested form may be downloaded from the web. The form is also available in Spanish.

Access by: mail, phone, in person, online.

Fee & Payment: The fee is \$5.00 per record. An additional fee may be charged if required information is not submitted. Use of credit card is an additional \$15.00 (thru VitalChek). Fee payee: NM Vital Records. Prepayment required. Personal checks accepted. Major Credit cards accepted only by VitalChek.

Mail search: Turnaround time is up to 6 weeks. SASE not required.

Phone search: From VitalChek, see expedited services. Phone is 800-255-2414.

In person search: Turnaround time is usually 1 hour or less.

Online search: See expedited service. This is a look-up at www.usgwarchives.net/nm/deaths.htm for deaths 1899 to 1940.

Expedited service: Expedited service is available for online, phone and fax requests from www.vitalrecordsnm.org/vitalrecords.shtml. Extra fees are charged, including delivery if needed.

Marriage Certificates, Divorce Records

Records not maintained by a state level agency.

Copies of marriage licenses are available from the County Clerk of the county where the marriage license was issued. Copies of divorce decrees are available from the District Court where the court order was filed.

Access to Records is Restricted.

The subject must write the agency, provide proof of ID with a driver's license, and request the record, and pay a copy fee of \$.25 per page. Most records are confidential but access is permitted for all parties to a case and other cases involving the same worker. Only upon filing of rejection of a recommended resolution shall records be open to the public.

Copies of tickets may be obtained from the same address. There is no fee.

Indexing & Storage: Records available for 3 years for moving violations; 25 years DWIs. Accidents are not reported on the record and neither are violations less than 10 mph over the limit in 55 or 65 zones. The driver's address is included on the record. New records available for inquiry in 30 to 40 days.

Searching: State law lists 9 permissible user groups and permits release of records with written

consent. Purchasers may not use the information for direct mail solicitation or resell the reports after usage. The driver's Social Security Number or license number, and name and date of birth are needed when ordering. Casual requesters must have signed, notarized consent from subject to receive records with personal information. This data not released: Social Security Number, address, and date of birth.

Access by: mail, in person, online.

Fee & Payment: There is no fee for mail-in or over-the-counter requests. Fee payee: Motor Vehicle Division. Prepayment required. Personal checks accepted. No credit cards accepted.

Mail search: Turnaround time: 10 to 15 days. No fee for manual search. A SASE is requested.

In person search: No fee for manual search. Up to 10 requests can be processed while you wait, the rest must be in writing and left overnight.

Online search: The New Mexico MVD contracts with New Mexico Interactive to provide all electronic media requests of driver license histories, title, registration and lien searches. Records are available to subscribers that meet federal and state standards. The annual subscription fee is \$75 for up to 10 users. The fee for a driving record is \$6.50, a non-hit result incurs a fee. Both single inquiry and batch modes are available for driving records. Monthly billing is provided. Details on the Court Structure

The **District Courts** hear felony, civil, tort, contract, real property rights, estate, exclusive domestic relations, mental health. They handle appeals for administrative agencies and lower courts, miscellaneous civil jurisdiction; and misdemeanors.

The **Magistrate Court** handles tort, contract, landlord/tenant rights, civil, (\$0-10,000); small claims, felony preliminary hearings; misdemeanor, DWI/DUI and other traffic violations.

Municipal Courts handle petty misdemeanors, DWI/DUI, traffic violations, and other municipal ordinance violations. The **Bernalillo Metropolitan Court** has jurisdiction in cases up to \$10,000.

County Clerks hold the case files for "informal" or "uncontested" probate cases seen by the Probate Judge. The District Courts hold case files for "formal" or "contested" probate cases.

Record Searching Facts You Need to Know

Fees and Record Searching Tips

In low-populated counties in New Mexico there are some "shared courts" – meaning one county handling cases arising in another. Records are held at the locations indicated in the text. Of the courts who will do a search, only a handful charge a search fee. Most District Courts charge \$.35 per copy and Magistrate Courts \$.50 per copy. Most District Courts charge \$1.50 for certification; the certification fee at Magistrate Courts varies widely.

The page at www.nmcourts.gov/caselookup/app offers free access to the District Courts and Magistrate Courts case information statewide (except for criminal records prior to February 27, 2014 from the Bernalillo Metropolitan Court, see below). In general, all other lower court records are available from June 1997 forward except:

- Municipal Court data is limited to criminal Domestic Violence and DWI historic convictions from September 1, 1991 forward.
- The site does not display Family Violence Protection Act Order of Protection cases on its Case Lookup Website (effective July 1, 2008). To access juvenile or order of protection information, please contact the court in which the case was filed.

Search by name & DL and/or DOB, and by county and type of case or by case number. Case lookup does not display the full date of birth, it displays only the year of birth. In addition, driver's license numbers are not displayed on records. A disclaimer reads: "Use of this site for any purpose other than viewing individual electronic court records, or attempts to download multiple records per transaction, are strictly prohibited." There is also a separate look-up for DWI Reports and DWI Offenders
